- (iii) The students who come forward voluntarily to appear for the examinations need be admitted without disturbance to their normal work.
- (iv) The Hindi teachers can undertake the work in connection with the above examinations without prejudice to their normal work.

The Kerala Hindi Prachar Sabha will make its own arrangements for collecting the fees from the pupils. The Sabha will fix the date of examinations every year which should be a Saturday during the third term of the academic year. The Director of Public Instruction will inform the Sabha in January every year the schools in which such examinations are to be conducted.
